Financial Aid reserves the right to retroactively rescind an award based on the date that a student's citizenship changes regardless of when a student notifies the school.

## Conditions of Institutional Financial Aid

- 1. This award is granted by term and academic year. Please note: for MD students the amount of award offered per term will be applied to the combined Term 3/Term 4.
- 2. If you repeat coursework, this award will not be applied to the terms with repeated coursework.
- 3. Award may be prorated in the event tuition is adjusted due to leave of absence or withdrawal.
- 4. This award shall be null and void if false information is discovered on Admissions or Financial Aid supporting documents/applications This award can be rescinded if the student is subject to disciplinary action due to misconduct.
- 5. If the student receives other financial aid from outside sources, s/he must inform the Office of Financial Aid immediately. This may affect other awards received.
- 6. St. George's University does not guarantee additional financial aid if any of the student's estimated resources are not available, if the student loses eligibility for the award, or if s/he chooses to decline any part of this award.
