**Enrolment Recommendations or Restrictions**

- York University offers English as a Second language (ESL) credit courses for undergraduate students, designed to enhance students' English language proficiency, academic skills and multilingual competence. The courses count as General Education and elective degree credits, and are strongly recommended for students from an ESL background. With maximum 25 students per class, the courses support student success in their degree programs, and the transition to university study, especially in their first year at York. Please speak to your academic advisor about enrolment in these credit ESL courses.



York has implemented a **COVID-19 Vaccination Mandate ([go.yorku.ca/vaccine-mandate](https://go.yorku.ca/vaccine-mandate))** based on the recommendation of public health officials. Universities are required under the Reopening Ontario Act to implement the recommendations of public health authorities.

Students are required to:

Subject to permitted exemptions under the Ontario Human Rights Code, your ability to participate in in-person activities is conditional upon you attesting that you are fully vaccinated with a course of approved vaccines under York's COVID-19 Vaccination Mandate and submitting proof of vaccination while the Mandate remains in effect.
