I am pleased to inform you that you have been made a **Conditional** offer to study the above programme at King's College London.

This offer is **Conditional** on you meeting the following requirements:

**Obtain the School Leaving Certificate from Class XII from either the CBSE or CISCE examination boards with an overall average of 93% across all subjects including 90% in Mathematics.**

**English Language condition: obtain an acceptable English language qualification from Band D: [www.kcl.ac.uk/ug-elr](http://www.kcl.ac.uk/ug-elr)**

You must meet **all** conditions of your offer in order to secure your place on the programme.

For a number of qualifications, we receive the results direct from UCAS via the Exam Board, and details of those qualifications can be found here: <https://www.ucas.com/undergraduate/results-confirmation-and-clearing/sending-exam-results>. If we do not receive your results direct from UCAS, you will need to ensure they are sent direct via King's Apply as soon as you have received your official results. We are unable to accept provisional or unofficial results, and where evidence is not in English, an official English translation must also be provided.

If your offer indicates a specific deadline, you **must** provide evidence by this date. With the exception of those offers which have a specific deadline in the offer, the final date on which the University will be able to accept any results is 31st August 2022.

If the official date your results are released is after the deadline applicable for your offer, you should send a message via King's Apply to confirm the date on which you will be able to provide evidence. The Admissions team will then be able to advise further.

If we receive your final official results and you then request a remark/appeal to your School/College/University or Exam Board, then we will be able to consider the remarked results as long as the official final remarked grade evidence is provided to the Admissions team by the latest 31st August 2022. The University will be as flexible as possible where remarked grades meet the conditions of the offer, however, this is dependent upon spaces being available, and where spaces are not available, a deferred space for the following year will be given. This is with the exception of programmes with an August start date, where the final date for remarked grades is 29th July 2022.

**About your offer**

It is very important that you check all the terms of your offer carefully, and notify us of any potential concerns. If you change the qualifications or subjects you are studying, you must inform us immediately, and we reserve the right to adjust your offer in light of any changes you make.

**If you have already taken qualifications that you believe meet, or partially meet, the conditions of your offer (including any English language condition), please upload evidence of your results via King's Apply as soon as possible, and no later than two weeks of accepting your offer. If you have added your IELTS or TOEFL details to your UCAS application, please inform us via a King's Apply message in order that we can verify your results.**

If your exam results will not be sent automatically through UCAS via the Exam Board, you will need to upload evidence of your results via King's Apply, normally as a scan of your paper certificate. If your certificate/transcript is not in English, you will also need to send an official English translation.

If we receive your results after the stated deadlines, we cannot guarantee that we will be able to offer you a place for entry, even if you have otherwise met the terms of your offer. We may contact you via King's Apply to request that you provide us with additional information about your application or supply copies of certificates/transcripts for any other qualifications or English language tests that you have declared as complete on your original application. If you fail to provide the requested information by the deadline we set, your offer may be withdrawn.

It is important that you **check King's Apply regularly** for updates, and inform us immediately if your contact details change.

This letter contains important information about your offer and the next steps you need to take. ### **Your Fee Status**

Based on the information you have provided, you have been allocated Overseas fee status.

This means your tuition fee for 2022/23 will be **£29460**.

Your tuition fees may be subject to increases in subsequent years of study, and you should bear this in mind when considering your offer. However, the fee paid for each subsequent year of study shall not exceed a 5% increase on the preceding year's tuition fee for the programme in question. Further details are available in the Terms and Conditions document on your offer page.

Please note: The UK Government has confirmed that EU, EEA and Swiss students commencing their studies from the academic year 2021/22 (after 1 August 2021) will no longer be eligible for home fee status or student finance. Fees for these students will therefore be charged in line with overseas fees from the 2021/22 academic year onwards however, these changes will not affect those EU, other EEA and Swiss nationals benefiting from Citizens' Rights under the EU Withdrawal Agreement, EEA EFTA Separation Agreement or Swiss Citizens' Rights Agreement respectively. It will also not apply to Irish nationals living in the UK and Ireland benefiting under

### **Deposit**
